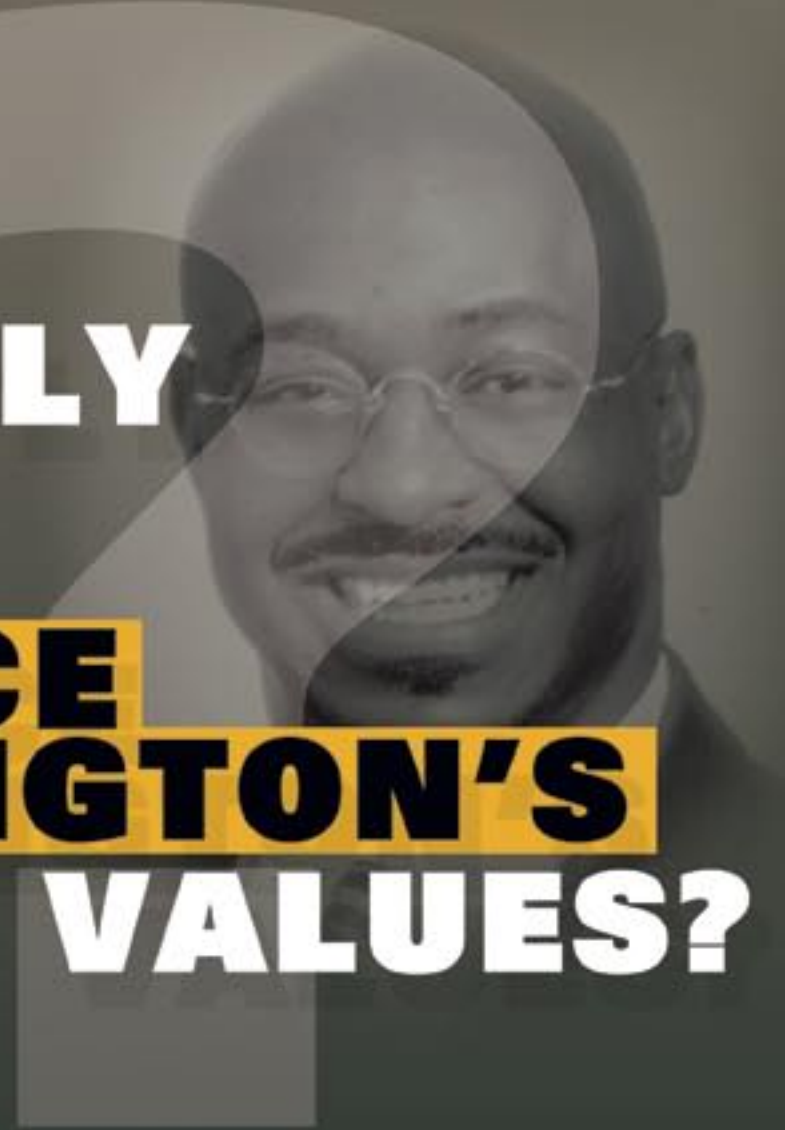

Alfredo Amezaga says state senator Maurice Washington owes a northwest Reno neighborhood an apology...



Until the city ordered the house closed on March 22, Amezaga said he and his neighbors had to contend with up to 30 parolees living in the home on Irving Park Circle.

"If you have enough power, you don't have to play by the rules..." Amezaga said. "You expect a senator to bring up a community, not bring it down." ...

[Reno Deputy City Attorney Creig] Skau also said at the hearing that drug use and prostitution were occurring at the Irving Circle house.

# PROSTITUTION AND DRUG USE AT A HALFWAY HOUSE RUN BY MAURICE WASHINGTON??

**Maurice Washington owes us all an apology.**



Reports that Senator Maurice Washington used his influence to keep open a halfway house that he operated – even after the city ordered it closed for drug use and prostitution – prove that Washington doesn't share the values of most of us in northern Nevada.

**And worst of all, Washington put this neighborhood in jeopardy simply for the money.**

The city also reported that Washington's halfway house was licensed for five residents, but had up to 30, for which he was paid up to \$18,000 a month (*Reno Gazette-Journal*, September 16, 2002). When Washington was asked to account for the extra payments, he wasn't able to explain where the money went, who benefited or how it was used.

**That lack of accountability is a recurring pattern in Maurice Washington's long political career.**

In addition to the unaccounted-for funds at his halfway house, a complaint was recently filed against Washington for misuse of funds at his church.

Just this month, another complaint was filed against Maurice Washington – this time for using church assets to benefit his political campaign.

**Maurice Washington is the problem because he doesn't share our values.**
